

# NITOC Balloting Guidelines Speech and Debate

#### I. Procedure:

- A. Judges should wear their official NITOC name tag given to them at check-in.
- B. In debate, a blind Ballot Push procedure will be followed in which a ballot will be turned over in front of the potential judge and confirmed for no club or personal conflict.
- C. In speech, Stoatrax "flags" ballots from your club so a different ballot may be found.

For a more detailed explanation of the Ballot Push procedures, please see the *NITOC Balloting Procedures* under NITOC 2019 Documents.

## II. General Judge Eligibility:

- A. Judge must be at least age 18 by January 1, 2019.
- B. Judge must not have competed in high school forensics during the 2018-2019 tournament season.
- C. Judge must be a high school graduate.

## **III. General Judging Guidelines:**

#### A. Judges MAY:

- 1. Judge students from their own state or region
- 2. Judge the same student in multiple speech events
- 3. Judge the same debate student/team in different debate events

#### B. Judges MAY NOT:

- 1. Judge students from their club, their own children or relatives
- 2. Judge students they have personally coached
- 3. Judge the same student more than once within the same speech event
- 4. Judge a debate student/team more than once within each form of debate

## C. A reminder to all judges:

- 1. Do not disclose speech results to anyone during the tournament
- 2. Do not disclose debate decisions to anyone during the tournament

## **IV. Judging Limitations Guidelines for Outrounds:**

A. When these additional guidelines apply:

- 1. Parliamentary debate: quarterfinals onward
- 2. Team policy debate: outround 5 onward
- 3. Lincoln Douglas debate: outround 5 onward
- 4. Speech: semifinals onward
- B. Judging limitations:
  - 1. Parents may not judge events in which their child is still competing
  - 2. Alumni may not judge events in which their sibling is still competing
  - 3. Coaches, parents, and alumni may not judge events in which a student they coach is still competing

# V. Additional Guidelines for Parliamentary Debate

- A. Coaches, parents, and alumni may assist teams during preparation time and then judge other teams for the same debate round until quarterfinals
- B. Coaches, parents, and alumni may not judge during the quarterfinal, semifinal, or final rounds if they help any team during preparation time

# VI. Judge Panel Size

- A. Debate:
  - 1. Prelims: One (1) judge panel
  - 2. Early outround: Three (3) judge panels, primarily parents, but community and alumni as available
  - 2. Semifinals (or outround 8): Seven (7) judge panels
  - 3. Finals: Nine (9) or more panels
- B. Speech:
  - 1. Speech Prelims: Three (3) judge panels
  - 2. Quarterfinals: Three (3) judge panels
  - 2. Semifinals: Five (5) judge panels
  - 3. Finals: Seven (7) judge panels

#### VII. Preferred Panel Composition

- A. 5 Judge Panels:
  - 1 parent
  - 1 alumni
  - 1 community
  - Additional two judges not specified
- B. 7 Judge Panels:
  - 2 parents
  - 2 alumni
  - 2 community
  - Additional judge not specified
- C. 9 or more Judge Panels:

- 3 parents
- 3 alumni
- 3 community
- Additional judges not specified

The tournament directors reserve the right to sacrifice any of the guidelines in order to keep the tournament running on time.
